Key Deadlines

REGISTRATION OF COMPANY

- All Person-In-Charge (PIC) have to register their company by 18 October 2019
- Individual links will only be released via the company's dashboard after payment has been made
- The option to opt for delivery services will no longer be valid from 20 August 2019

INDIVIDUAL REGISTRATION LINKS

- PARTICIPANTS WITH DELIVERY: Register by 23 September 2019
Participants with delivery who register after 23 September are to collect their race packs in person at the Race Entry Pack Collection (REPC)
- ALL OTHER PARTICIPANTS: Register by 22 November 2019
